PAYMENT TERMS

U.S. Funds Only.

Prepayment or C.O.D only For Customers without account, Net 30 days from date of invoice (upon approval of credit).

A complete credit application and resale tax certificate must be on file.

A late fee of 1.5%, or the maximum interest rate allowed, will be charged for each month that an invoice remains unpaid. Any past due accounts will be put on credit hold and/or turned over to a third-party collection, in which case the purchaser agrees to be responsible for all costs of collection and reasonable attorney fees.

PRICING

All prices are subject to change without notice and F.O.B. our warehouse unless previous agreed to in writing.

QUOTATIONS

The price and delivery quoted will be valid for sixty (60) days from the original date quoted, subject to material availability at time the order is actually placed.

SHIPPING

All orders are shipped F.O.B. shipping point. Title to the goods sold hereunder shall pass to the customer when the customer pays all amounts due to **TOOFast Supply**. Risk of loss and/or damage to the goods shall pass to the customer when the goods leave shipping point for delivery to the customer.

RETURNS

Specially Manufactured parts will have a 100% restocking or cancellation fee if they are in production or if the material has been purchased. All stock items will have a 20% restocking fee. (Subject to requirements as follows)

- 1. Product must be returned in original factory boxes or kegs.
- 2. Product must be returned in resalable condition or in a condition that is returnable to the manufacturer.
- 3. Pre-authorization is required.
- 4. RMA number is required.
- 5. Credit will not be applied to customers account until inspected and accepted by TOOFast Supply.
- 6. Freight must be prepaid when retuning for credit or shipment will be rejected.
